

Minutes of the meeting held on Monday 15th June 2020.

This was our first KCA meeting since February due to the Covid-19 pandemic. The meeting was held via group video call on Zoom.

Matters Arising.

Lease -

There has been correspondence via email regarding the lease, Shirley feels that we have an issue with the insurance. The surveyor has said that the hall is worth more than we have insured it for. They believe that the hall would cost £350,000 to rebuild, we are currently insured for £315,000 and don't have legal fees covered, giving a shortfall of at least £35,000, Shirley doesn't want the KCA and trustees to be held liable for the shortfall should anything happen. It was agreed that the insurance documents need to be kept safe and secure, so they are easily accessible. The insurance documents also need to be in the names of the KCA and the trustees.

Diana – The insurers have suggested that we have the hall revalued every five years. It is due to be revalued which falls in line with the renewal of the lease.

Shirley – We need to appoint official trustees through the charity commission.

Terry – The church solicitor has suggested that the Parish Council be approached. The Parish council have been and have asked questions that have not been answered yet.

"Having been involved in charity governance, my understanding is that the Kilburn Community Association are their own independent registered charity and unless their constitution stipulates that they are allowed to appoint custodian trustees, it would be illegal to do so."

"If the Kilburn Parish Council become the Custodian Trustee as a body, and not individuals, can it be checked that the yearly donation the Kilburn Parish Council make to the KCA is not a conflict of interest as far as the charity commission are concerned?"

Terry will contact Sheila Matthews to confirm their thoughts. Adrian to chase the solicitor for an answer to the Parish Council's queries.

Some paperwork seems to have the numbers 7-9, others have 7a and some just state Kilburn Village Hall. The houses either side are 7 and 9. Shirley believes that Royal Mail have the hall registered as 7a, Diana asked her if she could find something to confirm that.

Terry – Terry is going to contact Kevin Buttery about the government grant. We do not seem to have the account number that is needed as we do not pay business rates. This is because the hall is classed as a place of worship.

Shirley – A £500 hardship grant have been received. This is to keep the hall in good order during the Covid-19 pandemic and must be spent on keeping the hall available to use in an emergency or for a charitable cause such as the food bank.
